Form 941 - Employer's Quarterly Federal Tax Form

The current Social Security rate is 6.2% both for employees and the employer. The Social Security wage limit changes each year. This limit is the maximum annual pay subject to Social Security tax. The Medicare tax rate is 1.45% each for employees and employer, unchanged from 2013. There is no wage base for Medicare tax.
