The five (5) day notice to quit is a form to be used, where applicable, to notify a tenant that they are in non-compliance with their lease due to a violation.

[Arizona 5-Day Notice to Pay or Vacate Form Notice to Quit](#)

An Arizona 5-Day Notice (Non-Payment of Rent) form is used for the purpose of notifying the tenant that they have no more than 5 days to pay unpaid rent. If the tenant fails to pay the landlord the unpaid rent in full within the allotted 5 days, the tenant must vacate the property. On the 6th day, the landlord can file a forcible detainer action with the court to move ahead with the eviction.
