Your deadline for filing a motion to set aside the default depends on the specific reason you are asking the judge to set the judgment aside. If you are asking the judge to set aside your default judgment:

For example, in federal court, you can file a motion to set aside judgment for the following reasons: Mistake, surprise, excusable neglect, or inadvertence. For example, if your lawyer made a decision without your authority to do so, then you might be able to set aside the judgment. When can a default judgment be set aside? - Duensing Law

The motion to set aside the default judgment should be made as soon as possible after the applicant becomes aware of the judgment. The moving party's affidavit must set out circumstances under which the default arose that give a plausible explanation for the default; and The moving party must set forth facts to support the conclusion that there is at least an arguable case to
